Upon my arrival, I spoke to COM/GEORGE A. MIHALEK who advised that when he arrived at work this morning, he saw that the west side of the building had been spray painted overnight. MIHALEK advised he contacted his supervisor about the damage. MIHALEK was unable to contact LPD until now. MIHALEK advised the rear of the building was intact when employees left yesterday around 1530 Hrs. MIHALEK added that the gate to the parking lot was not secured last night.
