THE AFFIRMATION OF THE OHIO ATTORNEY GENERAL AND RULING OF CUYAHOGA COUNTY PROBATE COURT ALLOWED FOR THE FOUNDATION TO KEEP ALL OF THE FUNDS WHEN THE ORGANIZATION AMENDED ITS ARTICLES OF INCORPORATION. WITH DIRECTION FROM LEGAL COUNSEL, IT WAS DECIDED BY THE BOARD THAT THE TEMPORARILY RESTRICTED FUNDS COULD BECOME UNRESTRICTED. IT WAS ALSO DECIDED THAT FOR ALL BUT A FEW PERMANENTLY RESTRICTED FUNDS PRINCIPAL WILL REMAIN RESTRICTED AS ENDOWMENT AND INCOME WILL BECOME UNRESTRICTED DUE TO EXPIRATION OF NOTED PROGRAMS/SERVICES. ADDITIONALLY, THE THIESSEN AND HCS DONOR AGREEMENTS WERE REVIEWED BY LEGAL COUNSEL, WITH THE FOLLOWING CONCLUSIONS: THAT THE THIESSEN FUND DOES NOT NEED TO REMAIN AN ENDOWMENT AND CAN BE CATEGORIZED AS AN UNRESTRICTED FUND; THAT THE HCS ENDOWMENT FUND INCOME CONTINUE TO BE USED AS NOTED IN THE DOCUMENT. \$40,000 OF FUNDS WAS TRANSFERRED TO PERMANENTLY RESTRICTED AND \$1,084,940 WAS TRANSFERRED FROM PERMANENTLY RESTRICTED TO UNRESTRICTED AS OF DECEMBER 31, 2016.
