FURTHER, THE CLEVELAND CLINIC AND LAKEWOOD HOSPITAL ASSOCIATION HAVE BOTH COMMUNICATED THEIR CONSENT TO THE TRUSTEE'S DISTRIBUTION PLAN AND THOSE ENTITIES HAVE INDICATED THEY WILL NOT PURSUE ANY BENEFICIAL INTEREST IN THE TRUST FUNDS.

ACCORDINGLY, THREE ARCHES FOUNDATION HAS REDUCED THE VALUE OF THE ASSETS HELD IN PERPETUAL TRUSTS AS OF DECEMBER 31, 2018, BY 50% TO \$1,695,373.
