On 11/12/2021, at 1129 hours, Lakewood units were detailed to 15027 Detroit Avenue (Starbucks) for a report of a male threatening teenagers with a gun. The RP- LAUREN BARKLIANO described the male as white, in his thirties, wearing a grey/black camo long sleeve shirt, grey baseball cap, and black pants. The male was last seen going into The Root Cafe.

Officers arrived on scene at 15118 Detroit Avenue (The Root Cafe) and went inside. Due to the nature of the call, INV. JAMESON was carrying his patrol rifle. After checking the restaurant's seating area, officers went into the basement where they observed a male wearing a grey/black camo long sleeve shirt, grey baseball cap and black pants. Officers detained the male in handcuffs and patted him down for any weapons. The male identified himself as IO- ALEX TOZSER, an employee of The Root Cafe. After checking TOZSER for weapons and not finding any, the handcuffs were removed. TOZSER was advised of the complaint. TOZSER advised the following:

TOZSER did not have a gun. There were kids at Starbucks and they were threatening him. The one student, IO- REYES, lifted up his hooded sweatshirt with his hands in the pocket, exposing his waist band as if he had a gun, but TOZSER did not see a gun. TOZSER put his hand in his jacket and pulled his hand out shaped like a gun.

There were two other employees in the basement with TOZSER, a female and male, when officers arrived. They said TOZSER did not have a gun and that the kids at Starbucks were threatening TOZSER. The two employees were less than cooperative. Other employees later asked the officers to leave after releasing TOZSER because they did not feel comfortable with the officers there. It should be noted that it appeared that TOZSER has a mental disability.

Officers spoke with the principle, BARKLIANO, and she advised the following:

Her students from Albert Einstein Academy walked over to Starbucks. One of her students, REYES, called her and told her that there was a white male, TOZSER, threatening him with a gun. BARKLIANO ran over to Starbucks. The students gave her the description of TOZSER and said that he put his hand in his coat and pulled out a gun, waving it in the air.

Officers spoke with REYES and he advised the following:

REYES and his girlfriend, IO- MITCHELL, were walking to Starbucks from Albert Einstein Academy. TOZSER was walking on the opposite side of the street from them. TOZSER continued to look over at REYES and MITCHELL. TOZSER and REYES were arguing back and forth. REYES put his hands in his hooded sweatshirt and exposed his waistband. TOZSER gave REYES hand signals that REYES believed were gang signs. TOZSER put his hand in his jacket and pulled his hand out shaped like a gun. REYES did not see an actual gun.

MITCHELL was sent back to school by BARKLIANO before I could get her information. The indexed information on MITCHELL was all the information I was provided with by REYES and BARKLIANO. BARKLIANO called REYES' parents about the incident.

There was only one 911 call about the male with a gun which was from BARKLIANO. The 911 call was uploaded to Evidence.com.
